



Dear Jay Knable:

Greetings I send you from Leicester. This is a response to your letter dated July 26, 2006 in regards to an Audit on d/b/a Canopy Rentals for Country Living (unregistered 1998?), d/b/a Tom Millington's (natural person; never registered) Tents. Activities largely including my preparation for the Addison Field Days and week long exhibit at the Addison Field Days have been cause in my delay with a prompt response. There are numerous and deep issues that must be discussed and resolved before any such audit could ever occur.

I am an Ambassador to Jerusalem (Israel), an Ambassador II Cor.5:20 for Christ Jesus, and an Ambassador of the Algonquin Wabanaki Sovereign Nation. These Nations have a long history of being relentlessly subjugated, driven away, and exterminated (persecuted) by uncultured regimes because of adherence to their religious beliefs. I have received high honor as represented by the prestigious Ambassador Award, and by the holding of a United Nations World Peace Academy Certificate which qualifies me as an International Educator of World Peace. Please understand that none of the cultures and Nations for which I belong as diplomatic official is tax minded. In fact this very practice is contrary to our teachings, customs, and moral law whose origins can be traced back several thousands of years without error. Understanding the Roman Empire in Jesus' day may assist you in setting the arena.

If it is a demand on your part for such an audit, it is required of you, first, to personally prove how jurisdiction is derived to make such an examination. You must satisfy this counter demand and demonstrate with substantial proof how it is that your Agency can "peacefully" dictate to persons their life affairs and beliefs especially when personal testimony and lifestyle bears witness to allegiance clearly belonging to other Sovereign Nations and Kingdom. The respecting of the "rule of law" as promulgated by international authorities is essential to the promotion of the development of friendly relations between nations. I impel you to study some of the many issues that confront you:

1). Usurpation by legal definition is "the *unlawful (emphasis added)* seizure or assumption of sovereign power. The assumption of government or supreme

power by force or illegally, in derogation of the constitution and the rights of the lawful ruler". The Constitution by which you are legally bound makes clear that "all officers of government... are their [the people's] trustees and *servants (emphasis added)*; and at all times, in a legal way, accountable to them." [\*1]

"The framers of the Constitution firmly believed in government under law. They wanted to protect the country from tyranny in any form. They believed that a misguided majority might be as dangerous to good government under law as a privileged minority or a power mad dictator." [\*2]

2). The State of Vermont by legal definition is an Artificial Persons; that is, "persons created and devised by *human laws (emphasis added)* for the purposes of society and government, as distinguished from natural persons". The State of Vermont is a secular democracy, and, in historical retrospect, it should be noted that "Liberty has never lasted long in a democracy, nor has it ever ended in anything better than despotism." [\*3] Furthermore, the United States War Department Training Manual in 1928 directly associated democracy with anarchy and communism. Lastly, a 1973 ruling declared "Secularism is unconstitutional ... preferring those who do not believe over those who do believe ... It is the duty of government to deter no-belief religions ... Facilities of government cannot offend religious principles..." [\*4] **If you are operating according to a specific religion, please openly declare it.**

3)."No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms." [\*5] taking special note of the legal definition of free: "Not subject to legal constraint of another. Unconstrained; having the power to follow the dictates of own will. Not subject to the dominion of another. Not compelled to involuntary servitude; used in this sense as opposed to 'slave.'" [\*6] Here is wisdom: "Well aware that Almighty God has created the mind free... that to compel a man to furnish contributions of money for the propagation of opinions which he disbelieves is sinful and tyrannical;" [\*7]

4). The present state of Foreign Affairs is that we are at War: not only overseas, but at war internally from within. Homeland Security (USA) has in partnership (a player on the same team): The United States Postal Service and the Salvation Army. [\*8] The Salvation Army's mission is an International movement of the Universal Christian Church to preach the gospel (Good News) of Jesus Christ. [\*9] I have daily involvement with this American movement purposed to preserve the blessings of true liberty. May you be educated and concerned that public awareness is growing: "Huffington's new book- **Pigs at the Trough: How Corporate Greed and Political Corruption are Undermining America-** documents how a select few are running the government, and the economy, into the ground for the rest of us while reaping profits for themselves." [\*10] Never forget that the "Communist record offers the most colossal (gigantic, huge) case of political carnage in history." [\*11] Heavy progressive *income tax* is a distinguishing trademark of Marxist Communism. Lastly, "The aim- understood by presidents, overlooked by many voters- is eternal mastery and control, which, naturally has a high price. Bacevich's [\*12] cool, balanced analysis is compelling, and recalls chilling words penned by James Madison [\*13] in 1795: '**Of all the dreaded enemies of public liberty, war is perhaps the most to be**

**dreaded, because it comprises and develops the germ of every other. War is the parent of armies. From these proceed debt and taxes. And armies, debts, and taxes are the known instruments for bringing the many under the domination of the few."**

5). The U.S. Marshall Plan of 1947 declared, especially in regards to Communism, "...Furthermore, **governments, political parties, or groups which seek to perpetuate human misery in order to profit there from, politically or otherwise, will encounter the opposition of the United States...**" A brief look at some manifest facts in Vermont :

a) From the Words of Governor Douglas himself, State of the State: "For all the quality of life we enjoy, a lifetime in Vermont is becoming financially out of reach for middle and low-income residents, many of whom are native Vermonters whose families go back generations." ... "But since Act 60 undermined that [local] control, property taxes have spun out of control." -Rutland Herald January 6, 2006. There is a saying, "Those who fail to learn from history are doomed to repeat it." The following verdict should, therefore, be contemplated: **"The power to tax involves the power to destroy."**

b) The issue of money and what constitutes as Constitutional and moral money between Nations is under scrutiny: World Net Daily's Whistleblower Magazine, July 2006, Feature Title on the front cover: **"The Federal Reserve: Fraud of the Century"**. "The Federal Reserve-which is neither part of the federal government, nor does it rely on monetary reserves- is an unconstitutional, unelected cartel that literally creates the devastating problems it was suppose to prevent." In fact, as July's Whistleblower documents, the Fed's new chairman, Ben Bernanke, *admits* that the Federal Reserve was responsible for the Great Depression. "We did it," Bernanke said, adding, "We're very sorry."

c) Civil Unions as signed into "law" by former Governor Howard Dean undermined the morality of sustainable societies. This was in clear violation of Vermont Constitution sub section 68 that restricts law making to those laws that prevent vice and promote virtue (moral excellence). Forbes Magazine, December 8, 2003, in an article entitled Holy Influence quoted Art Ally "that homosexuality led to the fall of the Roman Empire" ... and "No nation in the history of the world has ever survived moral collapse." The Christian religion makes known unequivocally that this practice is sin (morally wrong; a transgression against a known law of God). See Leviticus 18:1-24, Romans 1:27.


d) The practice of gambling *is* unethical. Vermont State sponsored games like Power Ball *is* gambling. It incites false hopes of wealth often involving needy families who are already in financial stress by deficit, and it entices addiction. Power Ball is merely a transfer of wealth in favor of the State; that is, from the poor to the rich. This practice is outright hypocrisy when the State of Vermont voices its "concern" of the Native Indians bringing in Casinos. Allow me to inform you that Christian Indians like Kelsey BeGaye,

Navajo President, abhors casinos and in the past has vetoed all attempts to bring in Casinos declaring, "This administration firmly believes in strengthening family values." Chief Reynold Choiniere of the Algonquin Wabanaki Sovereign Nation, Newport, Vermont, is also opposed to the practice of gambling. See Matthew 6:24, 1 Timothy 6:6-10

I will conclude with a strong emphasis concerning what the legal profession refers to as government *de facto* and government *de jure*: Government *de facto*- "A government actually exercising power and control, as opposed to the true and lawful government; a government not established according to the constitution of the nation, or not lawfully entitled to recognition or supremacy, but which has nevertheless supplanted or displaced the government *de jure*." Government *de jure*- A government of right; the true and lawful government; a government established according to the constitution of the nation, and lawfully entitled to recognition and supremacy and the administration of the nation, but which is actually cut off from power or control." [\*16] True Christians are neither in league with evil (wicked; harmful; injurious), nor those involved in chain conspiracy (where different activities are carried on with the same subject of the conspiracy in chain-like manner such that each conspirator performs a separate function which serves in the accomplishment of the overall conspiracy.) [\*17] Robert Muller, a former Assistant Secretary-General of the United Nations, has publicly stated: "In the battle between forces of *good and evil* (emphasis added) on this planet, no one can be neutral, you want to take sides.

Please have ears to receive the critical message as it emerges from the sum of the parts. I will not tolerate knowingly the continuation of funding, through any economic resources, to the corruptors against Christians, indigenous Indians, or any people who have the sacrosanct right to live at peace in respect of a higher order.
