ISSUE: PRISONS and CORRECTION- Jesus and Holy Scripture versus the State of Vermont

Inmates describe problems, Burlington Free Press, August 11, 2004;1B, 3B (The prison system came under fire after an investigation into seven inmate deaths since 2002.): "A panel of inmates at the Southern State Correctional Facility complained Tuesday about how hard it is to find places to live when they have completed their jail sentences. 'I've noticed inmates stuck here when they are eligible to be released,' said Mike Fay... Inmates repeatedly returned to their most pressing need- housing on the outside."
